VOORGESTELDE WERKSWYSE VIR OPKAK DEUR STALLETJIEHOERS OP SATERDAG 5 DESEMBER 2020

1. AGTERGROND

Daar is waardering daarvoor dat na die 10 dae se Kersmark uitstallers teen Saterdag 5 Desember wanneer die ingang tot die Kersmark gesluit word, haastig sal wees om op te pak. Oppak reëlings sal streng toegepas word om die oppak so vlot en vinnig moontlik met minimum risiko vir verliese deur stalletjiehoers te laat verloop. Soos met stalletjiehoers ooreengekom moet alle stalletjies teen 18:30 opgepak wees. Ons herrinner u ook dat Kersmark ongelukkig nie verantwoordelikheid kan neem vir voorraadverliese tydens die oppakproses nie.

2. WERKSWYSE

- 2.1 Die oppak-proses sal vanuit die Restauranttent bestuur word. Stalletjiehoers word versoek om daar vir die oppak van hulle stalletjies aan te meld. Koeldranke, koffie, tee en pannekoek sal tot 17:00 in die Restauranttent bedien word.
- 2.2 Uitstallers wat voor ingange staan sal gevra word om eerste hulle stalletjies op te pak. Die betrokke uitstallers sal direk gekontak word.
- 2.3 Die Kersmark se voordeur sluit om 16:00. Laaste aankomende kliente sal ingelig word dat hulle 'n billike tyd gegun word om items te kies en tot by die betaalpunte deur te beweeg.
- 2.4 Sodra die laaste kliënte verby die betaalpunte beweeg het, sal die gebou oopgeluit word om 17h00, en in die tent aangekondig word dat die stalletjies opgepak kan word.

PROPOSED PROCEDURE FOR PACKING UP STALLS ON SATURDAY 5 DECEMBER 2020

1. BACKGROUND

It is appreciated that on 5 December after the 10 days of the market everybody will be in a hurry to pack up and go! We, as organising team, would like to again make the following arrangements to ensure that vacating the stalls will happen as smoothly and quickly as possible, with minimum stock-loss risk for stall keepers. The proposed arrangements are explained below. As agreed with stall keepers, all stalls must be vacated by 18:30. We also remind you that Kersmark unfortunately can't accept responsibility for stock loss at unattended stalls during the packing-up period.

2. PACK UP ARRANGEMENTS

- 2.1 The arrangements will be managed from the Restaurant tent. Stall keepers are requested to report there before vacating their stalls. Cold drinks, tea, coffee, and pancakes will be served there up to 17:00.
- 2.2 Exhibitors standing in front of entrances will be asked to pack their stalls first. The relevant exhibitors will be contacted directly.
- 2.3 The front door will close at 16:00. It will be suggested to the last arriving clients what reasonable time they have to select items and move through to the tills.
- 2.4 As soon as the last clients have moved past the tills, an announcement will be made at 17h00, in the Restaurant, that the stall keepers can proceed to pack and remove their ware.
